### **Scope of this Privacy Statement:**

"MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" is bound by European Regulation 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data (General Data Protection Regulation – hereinafter referred to as "the GDPR") and Law 4624/2019 (Government Gazette 137/A/2019) on "Data Protection Authority, measures for the implementation of Regulation(EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and for the incorporation into national law of Directive(EU) 2016/680 of the European Parliament and of the Council of 27 April 2016 and other provisions", as in force at any time (hereinafter referred to as "the Law"). This Privacy Statement details all information necessary for the processing of personal data for the provision of the event "Demystifying EBSI: Seminar & Training - All you need to know about EBSI" as well as the policies and procedures implemented by MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL for the protection of the user's privacy. This Privacy Statement sets out the criteria as well as the terms and conditions under which MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL collects, processes, uses, stores and transmits the personal data of the project users, how it ensures the confidentiality of such information, including any law and/or regulation implemented or enacted in accordance with Union and national laws on personal data protection and electronic privacy, as well as any law and/or regulation amending, replacing, issuing or consolidating any of the latter, including any other applicable EU and national laws on the processing of personal data and privacy, which may exist in accordance with applicable law.

For the purposes of this Privacy Statement, the terms "data processor", "data controller", "third party", "supervising authority", "personal data", "processing", "data subject" shall have the meaning ascribed to them by applicable legislation on the protection of personal data.

In addition, for the purposes of the present, the following definitions shall also apply:

"User"- the online user of the <a href="https://grnet.gr/">https://grnet.gr/</a> and <a href="https://grnet.gr/">https://grnet.gr/</a> and <a href="https://grnet.gr/">https://grnet.gr/</a> to whom the data refers and whose identity is known or can be ascertained, that is, it can be determined immediately or indirectly.

### A. Purpose/s for processing the data collected:

MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL as data controller on behalf of the EBSI-NE project within the framework of the event "Demystifying EBSI: Seminar & Training - All you need to know about EBSI collects and processes the personal data of the persons who give their consent, for the following purpose / purposes:

- A. To register in the event "Demystifying EBSI: Seminar & Training All you need to know about EBSI"
- B. For communication purposes in the context of the event
- C. For technical support
- D. For promoting the "Demystifying EBSI: Seminar & Training All you need to know about EBSI" personal data of the participants (Photos, Videos) will be published on the following social media:

- E. For the implementation of the online event using the livestream platform of Diavlos.

GRNET S.A. – acting as data processor on behalf of the EBSI Project acting as data controller - collects and processes "users" personal data in the context of providing the event "Demystifying EBSI: Seminar & Training - All you need to know about EBSI" solely for the abovementioned purposes and only to the extent strictly necessary to effectively serve such purposes. These data shall be relevant, appropriate and not more than those required in view of the aforementioned purposes. They shall also be accurate and, if necessary, updated.

Furthermore, the aforementioned data shall be retained only during the period required as mentioned hereinabove, in order to accomplish the purposes of their collection and processing and shall be deleted after the end thereof (see below "Personal data retention periods").

#### B. Categories of personal data processed:

In the context of contact for the online event and for following information, the personal data that are being processed are:

- How did you find out about the event
- Timestamp of the consent
- 2. For the purposes B and C: to implement of communication regarding the event and the technical support of the event the personal data being processed are:
  - Name
  - Last name
  - Email address
  - Organization/Institution
  - Role in the Organization/Institution
  - · History of emails that have been sent
- 3. For the purpose D: for the photographic material/Promotion of photographic material of the "Event":
  - Photos
  - Timestamp of the consent
- 4. For the implementation of the online event using the "diavlos" platform. For further information please look at the <u>following link</u>:
  - The video and audio streaming of the online event
  - The IP address wherefrom the "user" connects to the platform
  - Connecting device details (device type, manufacturer, model, operating system)
  - Country
  - Total time of being connected

### C. Legal bases for processing

For the aforementioned purposes the processing of users' personal data is based on the provision of the data subject's consent, as required by Article 6 par. 1 par. A of GDPR.

It is noted that when registering for the event "Demystifying EBSI: Seminar & Training - All you need to know about EBSI the subjects may grant their consent for each processing purpose. Regarding the processing of personal data for archival purposes, the legal basis is the legitimate interest OF GRNET S.A. in preserving and maintaining the company's historical record and identity.

## D. Access to personal data:

For the implementation of the dispatch and processing of the event "Demystifying EBSI: Seminar & Training - All you need to know about EBSI" access to the personal data of "users" is provided to the following:

- The marketing team of GRNET S.A., which consists of staff that maintains a contractual relationship of project leasing and provision of services with GRNET S.A.
- > The coordination team of EBSI project.

The processing of the event's "users" personal data by the aforementioned, is carried out under the supervision and only at the request of MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL within the scope of the mission and the role of each associate. Such associates undertake to





comply with the same privacy and personal data requirements as MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL itself in accordance to the present Privacy Statement.

#### E. Recipients of collected personal data:

"MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" shall in no way transmit or in any way disclose the "users'" personal data to any third-party entities, private businesses, natural persons or legal entities, public authorities, agencies or other organizations, other than as expressly set out herein.

The "Users" personal data may be disclosed or transmitted to governmental authorities and/or law enforcement officials, only if necessary for the abovementioned purposes, in the context of enforcement of a court decision or a provision of law or if necessary to secure the legitimate interests of "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" in its capacity as data controller, in compliance with the terms and conditions of applicable law.

### F. Rights of data subject

As regards the data processed in the context of providing the event "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" as data controller – takes all necessary action, pursuant to the terms of this Privacy Statement, both during the collection as well as in every subsequent stage of processing of the "Users'" personal data, so that every "user" may exercise his/her/their rights, as laid out in applicable legislation on the protection of personal data, namely the rights of Access, Rectification, Erasure, Restriction of Processing, data Portability, in accordance with the terms and conditions of applicable law:

In addition, data subjects have the right, at any time, to withdraw their consent, without this withdrawal affecting the lawfulness of the (generally) processing that took place before its withdrawal.

For example, in the event that a "user" has given his/hers/their consent to download and (re)publish photographic material and this material is published/posted on social media of "GRNET S.A." or of the EBSI project, if he/she/they revokes his/hers/theirs consent, then "GRNET S.A." or "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL"will not make any new publication of the photographic material in question; however, it is pointed out that in this case and regardless of the intentions of "GRNET S.A." or "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL", the company will not be able to control any re-publications of the material in question on the internet by third parties or maintaining such material on social media.

The aforementioned rights of the data subjects are subject to restrictions in accordance with the applicable legislation.

"MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" provides the data subject with information on the action taken upon his request to exercise any of the above rights within one (1) month of receipt of the request. The aforementioned deadline may be extended by two (2) more months, in accordance with the terms of the existing legislation.

### G. Personal data retention period

The personal data of the "Users" in the context of the provision of the event "Demystifying EBSI: Seminar & Training - All you need to know about EBSI" are kept for the necessary period of time for the needs of the provision of the service and the controls to which the service is subject.





A consent withdrawal form is posted on the event's registration page. It is noted that the legality of the processing of personal data that took place in the context of the granted consent is not affected.

In any case, the duration of retention of personal data shall not exceed:

- For the purposes A), B) and C) herein six (6) months.
- For the purpose D) and E) herein until the withdrawal of consent.

The duration of retention of personal data by "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" sexternal partners/processors is specified in detail in the Contracts that "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" has signed with them, considering the object and purposes of processing.

## H. Technical and Organisational Measures:

The processing of personal data by "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL" is carried out in such a way as to ensure its confidentiality and security. Specifically, it is carried out exclusively by authorized associates of "MINISTERIO DE ASUNTOS ECONÓMICOS Y TRANSFORMACIÓN DIGITAL", while all appropriate organizational and technical measures are taken for data security and protection against accidental or unlawful destruction, accidental loss, alteration, prohibited dissemination or access and any other form of unfair treatment.
